# INVITATION FOR TENDERS

*“Development of the Design documentation, passing of the expertise of the project, designer’s supervision and execution of the works on replacement of the old fixtures with new LED ones, replacement of the overhead lines with SIW, installation of the control cubicles with GSM terminals for outdoor lighting control, installation of electricity metering cabinets, arrangement of protective grounding of polls, disposal of dismantled lamps”*

**Kreminna City Council**, hereinafter referred to as “the Employer”, intends to use part of the proceeds of a grant from the Nordic Environment Finance Corporation (NEFCO) towards the (cost) of “Development of the Design documentation, passing of the expertise, designer’s supervision and execution of the works on replacement of the old fixtures with new LED ones, replacement of the overhead lines with SIW, installation of the control cubicles with GSM terminals for outdoor lighting control, installation of electricity metering cabinets, arrangement of protective grounding of polls, disposal of dismantled lamps”.

The Employer now invites the Contractors to submit their tenders for the following contract to be funded by the grant, aimed at purchase of the materials and related work:

- Installation of new and replacement of obsolete LED fixtures, replacement of lighting polls, replacement of metal brackets, suspension of self-insulated wire, installation of street lighting control cubicles with measuring devices, installation of street lighting control terminals, installation of dispatch point, restoration of protective ground circuits for lighting polls, restoration of the re-grounding circuits, dismantling of all equipment to be replaced, with mandatory disposal and removal of dismantled materials in accordance with environmental requirements, as well as development of the design documentation with passing of the expertise and carrying out of designer’s supervision.

To be qualified for the award of a Contract, Tenderers must satisfy the following minimum criteria:

- the Tenderer, has the financial, technical and production capability and capacity necessary to perform the Contract, and Tenderer’s average annual revenue in the previous **three** years was at least **two** times greater than price of his tender. In case of tender submitted by JVCA, the leading partner should demonstrate at least 50% compliance with the requirement;
- the Tenderer has satisfactorily delivered similar plant and works to other Employers and completed at least **five (5)** similar Contracts in the recent **five** years;
- the Tenderer or its agent will be able to carry out warranty obligations;
- the Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- in the case of a Tenderer offering to deliver plant under the Contract which the Tenderer does not manufacture or otherwise produce, the Tenderer has been duly authorised by the plant’s manufacturer or producer to deliver the plants in the Employer’s country.

In preparation of their offers, the Tenderer should take into account that the works in this Contract will tentatively start on **April 2020** and continue to **December 2020**.

Tender documents, upon request from prospective Tenderer, will be sent by email free of charge in electronic format (PDF file). If requested to send documents in the written form, the documents will be sent by Employer to Tenderer on terms and conditions agreed by the two.

All Tenders must be accompanied by a Tender security in the form of tender-securing declaration whose form is provided in Tender Document. The purpose of Tender security is to ensure the Tenderers are serious about their participation.

The winning tenderer will have to provide performance security from a reputable bank acceptable to NEFCO.

Tenders must be delivered to the office at the address below before **12:00 p.m. 25.02.2020**, at which time they will be opened in the presence of those Tenderers’ representatives who choose to attend.

Pre-tender meeting of Tenderers with the Employer's representatives for visiting the project sites and discussion of technical and logistical issues will be held on *12:00 p.m. 28.01.2020* at the address: *Ukraine, 92905, Luhansk region, Kreminna city, Druzhby Avenue, 13.*
